A period of 6 months will be allowed to cut and remove said timber. All roads, fences, drainage systems, and terraces must be restored to their original condition. **A 5% PERFORMANCE DEPOSIT WILL BE REQUIRED AT CLOSING ALONG WITH A CASHIER'S CHECK FOR FIFTY PERCENT (50%) OF TOTAL BID AMOUNT FOR THE TIMBER. THE REMAINING BALANCE MUST BE PAID WITHIN 15 DAYS OF COMPLETION OF CUTTING OF THE TIMBER.** The tract must close within 30 days of bid acceptance.
