Committee Members Present: Kristen Noonan and Betty Tatro. **Abstain:** Lisa Steadman

Call the Meeting to Order: K. Noonan called the meeting to order at 6:09 PM

1. Public Comments: There were no public comments.

2. Approval of Minutes from 8/4/2026: MOTION: K. Noonan **MOVED** to approve the August 4, 2026 as presented. **SECOND:** B. Tatro. **VOTE:** K.Noonan-yes and B. Tatro-abstain. **Motion passes.**

3. Policy Review: K. Noonan explained the NHSBA Bulletin required by law policies. She shared the Policy Log to B. Tatro.

a. DAF: Administration of Federal Grant Funds: The committee reviewed Policy DAF which was part of the Special Bulletin with the red line edits. The committee last reviewed the policy in 2021 and the NHSBA in 2024. The committee filled in “Superintendent or designee” where needed. The recommendation for a competitive bid threshold has increased to \$350,000, sealed bids. There were a number of paragraphs added. The Davis Bacon Law was also added. DAF-6 had additional wording to be added to the section. The committee would like the Board to waive the second read and have the Board vote at the next meeting. This policy is regarding Federal Grants. **MOTION:** K. Noonan **MOVED** to update Policy DAF with the NHSBA Sample Policy, update with committee edits and ask the Board to waive the second read. **SECOND:** B. Tatro. **VOTE:** Unanimous for those present. **Motion passes.**

b. DFA: Investment: The committee reviewed Policy DFA. There is a revision, an RSA which requires an annual review of this policy. It states that the investments are not permitted to be covered by FDIC. There were changes reviewed by the committee. **MOVED** K.Noonan **MOVED** to update Policy DFA with the NHSBA Sample Policy and to forward to the full Board as a first read. **SECOND:** B. Tatro. **Motion passes.**

c. JICK: Bullying Prevention-Pupil Safety and Violence Prevention: Policy JICK is required by law. The MRSD Policy was reviewed along with the NHSBA Policy. The committee made edits and changes. Policy JICK is in the Student Handbook. **MOTION:** K. Noonan **MOVED** to update JICK with the NHSBA Sample Policy, with committee edits and to forward to the full Board as a first read. **SECOND:** B. Tatro. **Motion passes.**

d. JJJ: Access to Public School Programs by Non-Enrolled Residents: Policy JJJ is required by law. The committee made edits by adding “Director of Student Services” among others. **MOTION:** K. Noonan **MOVED** to update Policy JJJ with the NHSBA, with committee edits and to forward to the full Board as a first read. **SECOND:** B. Tatro. **Motion passes.**
