

2026-2027 STUDENT PARKING RULES & REGULATIONS

1. Students who are issued parking permits must park their vehicle in the appropriate assigned numbered space & lot within the student parking lot. Students may not park in the STAFF lot (North side of school). The hang-tag must be visible in the front windshield of your vehicle.
2. Student drivers who do not have a first period class and their last class of the day ends before 8th period will be issued a special hang-tag and will park in front of the school. Do not park in the area directly in front of the cafeteria. ONLY STUDENTS ISSUED A TOP LOT PARKING PERMIT CAN PARK IN FRONT OF THE SCHOOL.
3. Upon arrival at school, student drivers must immediately exit their parked vehicle and may not loiter in or around their vehicle or any other vehicle. The same rule applies when student drivers are dismissed at the end of their school day.
4. No loud music is allowed while on school property.
5. Once students have parked, they may not return to their vehicles during the school day, including lunch, without a pass from a school administrator. No teacher may grant such permission to a student. Students returning to their vehicle without proper authority will have their parking permit suspended or revoked.
6. The student and his/her parents/guardians acknowledge that they are aware that Calvert County Public Schools, its Board of Education, and Huntingtown High School do not assume any responsibility for damage or theft involving vehicles parked under this agreement. To that end, students are encouraged not to leave any valuables in their vehicles and to remove their keys and lock their vehicles after parking them.
7. The student acknowledges that he/she will be held personally responsible for any contraband discovered within their automobile, regardless of ownership of the vehicle. To that end, student drivers will ensure that no weapons of any type, alcohol, tobacco products or controlled dangerous substances are stored in any vehicle they park on school property.
8. The school administration has the right to search any student vehicle parked on school property.
9. No student will be issued a parking permit until ALL his/her financial obligations are satisfied.
10. Parking passes are non-transferable and may only be used by the student to whom they are assigned.
11. By entering this agreement, the student and the parent/guardian acknowledge that they understand, and that the student agrees to comply with all provisions of it. The student and his/her parent/guardian acknowledge that any violation of this agreement will result in the suspension of the student's parking privilege, in addition to any other sanctions imposed under the Student Code of Conduct. THERE WILL BE NO REFUND OF MONIES SHOULD PARKING PRIVILEGES BE REVOKED.

**Seniors and Juniors take precedent for parking passes.
NO PARKING PERMITS WILL BE ISSUED TO FRESHMEN.**

****Senior parking permits must be turned in one week before their last day, but seniors may continue parking in their assigned spots during their final week of school.****
