WHEREAS, Ohio Revised Code Section 3313.17 permits the Board to enter into contracts, including those contracts collectively bargained pursuant to Chapter 4117 of the Ohio Revised Code; WHEREAS, the Board has engaged in collective bargaining with the Willoughby Eastlake Classified Professionals ("WECP") during which the parties have come to an agreement effective August 1, 2026 through July 31, 2028; WHEREAS, the Board wishes to proceed with approving the collective bargaining agreement with WECP, effective August 1, 2026 through July 31, 2028 (the "Agreement"), though the parties expressly reserve the right to make any housekeeping and other revisions to the Agreement as necessary after the Board's approval of the Agreement pursuant to this Resolution in order to implement the tentative agreement previously entered between the parties in the course of collective bargaining; and WHEREAS, Section 4117.09 requires a collective bargaining agreement to be reduced to writing and executed by all parties.
