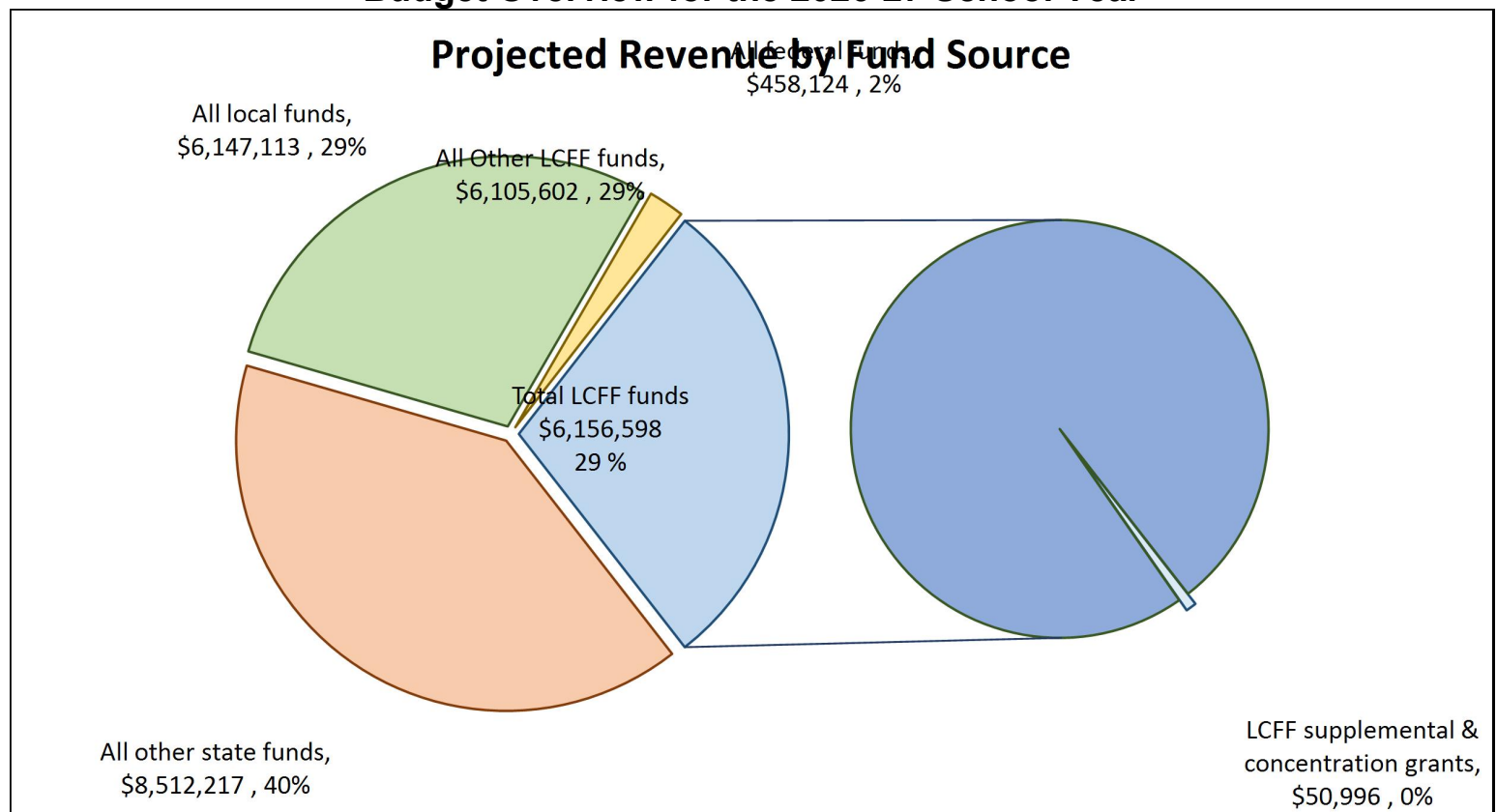

### Budget Overview for the 2026-27 School Year

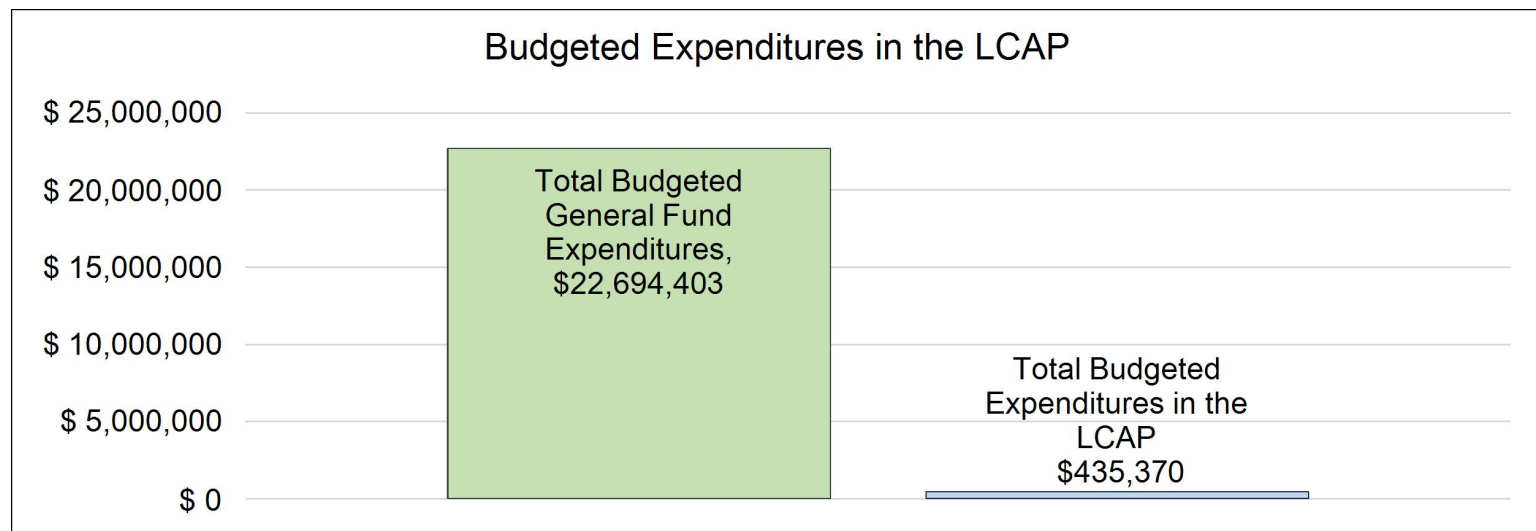


This chart shows the total general purpose revenue Lake County Office of Education (LCOE) expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Lake County Office of Education (LCOE) is \$21,274,052, of which \$6,156,598 is Local Control Funding Formula (LCFF), \$8,512,217 is other state funds, \$6,147,113 is local funds, and \$458,124 is federal funds. Of the \$6,156,598 in LCFF Funds, \$50,996 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

This chart provides a quick summary of how much Lake County Office of Education (LCOE) plans to spend for 2026-27. It shows how much of the total is tied to planned actions and services in the LCAP.

The text description of the above chart is as follows: Lake County Office of Education (LCOE) plans to spend \$22,694,403 for the 2026-27 school year. Of that amount, \$435,370 is tied to actions/services in the LCAP and \$22,259,033 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

LCOE expenditures outside of the LCAP include the state and federally imposed mandatory obligations and general operations of a county office of education. Other expenditures are related to grant awards received to fulfill specific outcomes.

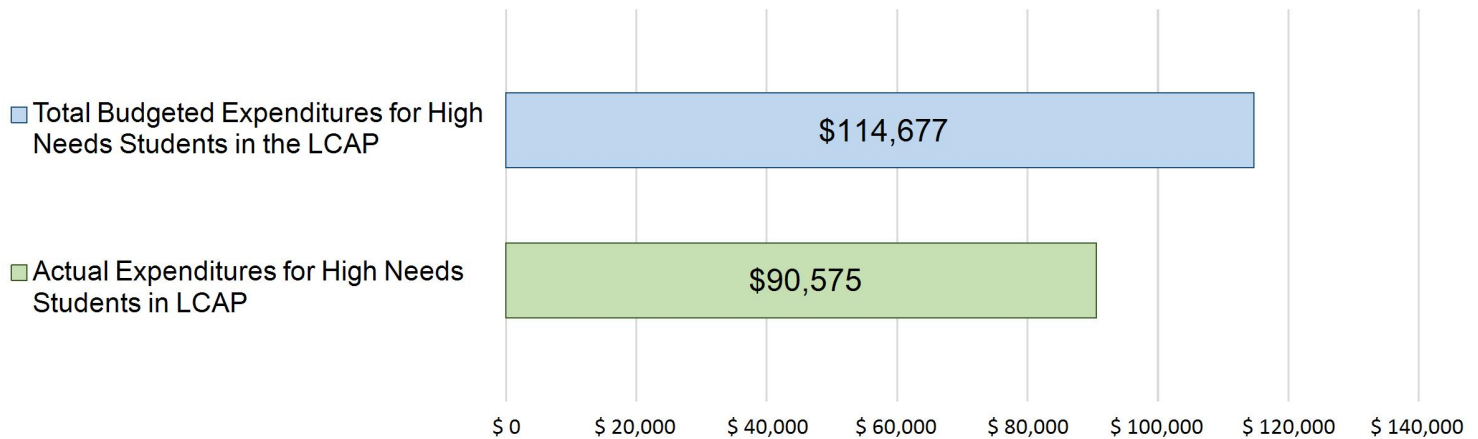
## Increased or Improved Services for High Needs Students in the LCAP for the 2026-27 School Year

In 2026-27, Lake County Office of Education (LCOE) is projecting it will receive \$50,996 based on the enrollment of Foster Youth, English learner, and low-income students. The text description of the above chart is as follows: In 2025-26, Lake County Office of Education (LCOE)'s LCAP budgeted \$114,677 for planned actions to increase or improve services for high needs students. Lake County Office of Education (LCOE) actually spent \$90,575 for actions to increase or improve services for high needs students in 2025-26.

The difference between the budgeted and actual expenditures of \$24,102 had the following impact on Lake County Office of Education (LCOE)'s ability to increase or improve services for high needs students:

The difference between the budgeted and actual expenditures was primarily driven by lower-than-anticipated spending on student incentives. Additionally, Project-Based Learning was fully funded through the SWP K-12 grant, while Restorative Practices (RP) was partially supported by RP grant funding.

## Plan Summary [2026-27]

### General Information

Lake County, home to the largest natural freshwater lake in California, is an isolated, rural county located 110 miles northwest of Sacramento, nestled among the inner coastal mountain range. The county has a population of approximately 64,500 residents, of which approximately 9,500 are school-age children.

Lake County's economy is based largely on tourism and recreation, due to the popularity of its several lakes. The largest employers in our county are the local government, school districts, two regional hospitals, and a growing agricultural base. Unfortunately, the city of Clearlake, the largest incorporated area in the county, was recently identified as one of the poorest cities in California. Overall, one in four county residents lives in poverty, with 28 percent of Lake County school-age children living in homes that are below the poverty line.

In the past decade, a number of natural disasters have impacted Lake County and its residents. In late summer of 2018, one of the largest wild fires in California history ravaged Lake County adding to the county-wide housing shortage. Since 2013, multiple devastating wildfires and flooding have displaced students and school staff alike. The long-term effects of losing homes and property has presented the community with additional challenges. While our region is challenged each year with the threat of natural disasters, the resilience of the community continues to persevere.

To support our Lake County students, the Lake County Office of Education operates two specialized schools - Clearlake Creativity School (CCS) and Lloyd P. Hance Community School (Hance). CCS provides educational opportunities for students with severe behavior needs in a counseling rich environment. The Lloyd P. Hance Community School provides an alternative learning environment for middle and high school

students (7th-12th grade) who are experiencing difficulties in a traditional school setting or who have been expelled from the comprehensive school setting.

#### Clearlake Creativity School (CCS):

CCS students come from schools across Lake County. They are referred through their school teams due to severe behavioral challenges that are impeding their success in their home district. Before students are enrolled at CCS, the student, parent/guardian and school staff meet to discuss student enrollment and to determine if CCS' programming would be of benefit to the student's current challenges. CCS is considered a regionalized program serving mostly a low socioeconomic population. Each classroom at CCS is staffed with a teacher, paraprofessional and a rehabilitation specialist. A full-time clinician (LCSW or MFT) is based at the school through our Behavior Health Student Services Act (BHSSA) grant and provides ongoing mental health services to all students enrolled in the CCS program. Students at CCS report feeling safe and connected at school.

#### Lloyd P. Hance Community School (Hance):

Hance is home to students who are working to improve their educational trajectory. Comprised of one general education teacher, one special education teacher, two paraprofessionals and one principal, Hance strives to provide students with an alternative approach to learning that places a larger focus on career exploration. Our data shows that students feel successful at Hance. They feel that they receive the support they need, both personally and educationally, to improve the circumstances that resulted in their placement. Many surveyed (parents/guardians, students, staff and community members) said that the school has many strengths including the school's flexibility and the caring staff. Hance is proud to host a graduation ceremony for students who complete their high school diploma during their time with us.

Both CCS and Hance continue to qualify for Equity Multiplier funds due to the low socio-economic student base and each school's non-stability rate of greater than 25%. This funding has provided a new school counselor at both sites to provide more college and career counseling to our middle and high school students.

#### Foster and Expelled Youth:

The Lake County Office of Education has served foster youth since 1998. Our COE Foster Youth Services Coordinating Program serves every foster youth in Lake County, providing education reviews and referrals for academic support. We have an Executive Advisory Council (EAC) which works to identify system needs, capacity building and interagency collaboration. We serve our youth individually and coordinate services with districts and agencies. Our Foster Youth Services Coordinating Program (FYSCP) has been highly effective in helping our foster youth graduate, as we provide countywide academic oversight for our foster youth, supporting their academic success.

## Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Due to the number of students at both CCS and Hance, limited CA School Dashboard data is available. Hance does not have enough students in any indicator to provide data through the CA Dashboard. CCS has one indicator, Suspension, that is present on their CA School Dashboard. In 2024, the CCS Suspension indicator moved to the Red level as suspensions increased 5% from the previous year with 20.6% of students being suspended at least one time. Below are data markers for CCS, Hance and LCOE as provided through Data Quest.

Transportation to Hance for students who live in southern region of Lake County has improved. While transportation for Hance continues to be a challenge, LCOE team members work with our school district partners to help support our students get to and from school. Additional collaboration is currently underway with the hope to secure a more consistent transportation plan for Hance students.

Academically, both Hance and CCS have engaged students in more project-based opportunities connecting their interests to career

exploration and academic learning. The PPS School Counselor has also made a positive impact on guiding students through more career and post-secondary explorations to help them prepare for life after high school. In 2025-26, Hance and CCS utilized the Strong Workforce Program (SWP) grant to improve the school gardens and career exploration opportunities. Additionally, CCS was able to have a designated garden area fenced with a storage area installed during the 2025-26 school year. The goal is to have a thriving garden space at CCS in the upcoming school year.

Learning Recovery Emergency Block Grant: Hance and CCS spent all LREBG funds in 2025-26 on Restorative Practices training based on the Needs Assessments which can be found in this public Google folder (<https://tinyurl.com/48t3vdkh>). Both schools work with students who have intense behaviors or who have experienced adverse experiences during their school career or at home. Research from the National Institutes of Health, Learning Policy Institute, and National Education Association all support Restorative Practices in the schools to promote a positive school culture, reduce suspensions and expulsions, and foster stronger student belonging in schools, especially those schools supporting students with intensive behaviors and/or expelled youth. The student population at both schools experiences a high student transient rate as students are enrolled and exit regularly throughout the school year. While attendance and suspensions continue to experience inconsistent improvement due to the high rate of new students enrolling and successful students returning to their home district.

California School Dashboard: Both Hance and CCS have revolving student numbers throughout the school year. Both schools are regional programs for the public school districts of Lake County. Because of this, they do not have the student numbers to display a consistent color status on the California School Dashboard. On the 2024 Dashboard, CCS had enough students to have color status in one Dashboard indicator - Suspensions (Red). This year (2025 Dashboard) CCS did not have enough students to have color status on any Dashboard indicators. On the 2024 Dashboard, Hance did not have enough students to have color status in any Dashboard indicators. This year (2025 Dashboard) Hance had enough students to have color status in one Dashboard indicator - Suspensions (Red). Both schools continue to work with the school counselor and mental health providers to offer students as much support as possible to address their diverse needs.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Lake County Office of Education participated in nine LCAP engagement opportunities as listed in the above section. At each engagement meeting LCAP planning was included and parents were invited to attend through teacher direct messages. At each meeting, the school programs at Hance and CCS were discussed sharing the main components of the NEEDS-SEB program and Big Picture Learning; the 2025-26 LCOE LCAP goals and actions were reviewed to gather feedback and input from the second year of implementation; all groups were asked for ideas on potential actions; all groups were briefed on how Equity Multiplier funding for both Hance and CCS were used and how those funds were leveraged to support students based on last year's input; students were asked to provide feedback on what they believed they needed to improve their academic and behavioral progress; parents were asked what LCOE could do to improve their student's

outcomes; and all participants were asked how LCOE could improve direct services. Suggestions were added to the LCOE 2026-27 LCAP Planning Document.

The LCAP was influenced by this engagement as it reinforced the need to continue with Big Picture Learning, the NEEDS-SEB program, the BCBA, and the PPS Counselor. Ongoing student support for daily living skills and providing more work-based learning options were stressed as high priorities. The Literacy Coach for CCS will remain at 75% FTE for the 2026-27 school year as this will be the last year of the LCRSET grant. The goal will be for the Literacy Coach to help transition her reading groups to the teacher and to support full implementation. All in all, LCOE continues to listen to our community partners to ensure our LCAP reflects the needs of our community.

## Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

This goal focused on improving the academic engagement of students at both CCS and Hance. In 2025-26, academic engagement was more robust as teachers provided more project-based learning opportunities for students that connected their interests to their school program. This implementation was primarily driven by Big Picture Learning at Hance and project-based learning at CCS. Teachers at Hance were successful in connecting student career interest to their Big Picture Learning plans as evidenced in successful student exhibitions that occurred quarterly. Teachers at CCS were able to engage students in more art and music classes as well as project-based learning. This is evidenced in the holiday performance and class projects. The main challenge at both schools is the constant turnover in our student population. Since students are referred to our schools for expulsion or for extreme behaviors, the student population is not consistent from one semester to the next, and oftentimes, student enrollment can fluctuate monthly. This leads to inconsistent patterns in program implementation.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

No material differences between budgeted expenditures and estimated actual expenditures occurred.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Action 1.1 - Hance continues to implement Big Picture Learning with greater fidelity. Students are engaged in more work-based learning and CTE experiences that directly aligns their academic program to the world of work. This action was effective.

Action 1.2 - STAR 360 continues to be used but requires greater consistency in its use with more time dedicated to analyzing student results. Aligning this tool with the CCS Literacy Coach is something we hope to implement in 2026-27. This goal was somewhat effective as student scores did show improvement.

Action 1.3 - Hance and CCS have Accellus as their adopted curriculum. After three years of trial with both Edgenuity and Accellus, the team has decided to continue using Accellus and to not renew the Edgenuity pilot contract. This action will not be renewed in the new LCAP three-year cycle.

Action 1.4 & 1.7 - Music classes, art classes and project-based learning were implemented this year with varying success. While students were fully engaged in these classes, we need to offer these opportunities more often within the school year. This will continued to be explored for the upcoming school year with greater emphasis on stronger implementation.

Action 1.5 - AVID: Staff participated in limited AVID training in 2025-26. LCOE team members will attend the 2026 AVID Summer Institute with the plan to work with Hance and CCS teachers more closely throughout the upcoming year to improve instructional strategies in classrooms.

Action 1.6 - We adjusted the Extended School Year for the 2025-26 school year to eliminate the need for a waiver. With the adjustment only 2 families have indicated that their children would participate in ESY in June and July of 2026. Unfortunately, due to the low attendance, both families have now declined ESY for 2026.

Action 1.5 was modified because CCS and Hance teams are not attending the AVID Summer Institute in the summer of 2026. Lake COE Ed. Services team will support CCS and Hance teachers to infuse more AVID strategies into their instructional program. All other actions and metrics remain unchanged.

An explanation of why the LEA has developed this goal.

Lloyd P. Hance Community School serves students who have been expelled from their district of residence and Clearlake Creativity School serves students who have been referred for extreme behavior needs. From the engagement meetings held, students and staff reinforced the need for additional student supports, specifically a school counselor and Board Certified Behavior Analyst (BCBA), so that a designated staff person (PPS school counselor) could support both schools with Character Strong, Restorative Practices and College & Career planning, and so that a BCBA could support students with extreme behaviors. Equity multiplier funds were targeted for BCBA support and PPS School Counseling support. Additionally, supplemental concentration funds generated by Lloyd P. Hance Community School only, will be directed to the PPS School Counselor position so that our expelled youth have more designated time for SEL supports. For this goal, social-emotional learning will be the cornerstone of teaching students how to regulate their emotions and Restorative Practices will be the vehicle to teach students how to address conflict and resolve differences.

## Goal Analysis [2025-26]

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Hance continues to see positive results in student belonging and school culture with the implementation of Big Picture Learning. The NEEDS-SEB program requires more training for staff. CCS administration has scheduled Dr. Clay Cook (co-author of the NEEDS-SEB program) to work with the CCS team to reinforce program components for greater fidelity of implementation. DEI training was braided into the Restorative Practices and Character Strong programs. The BCBA Senior Director was instrumental in providing key training to staff focused on universal design for learning, autism and evidence-based practices. Healthy Start remains an integral support for our school families.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

In 2025-26 CCS struggled implementing the NEEDS-SEB program with fidelity. Dr. Clay Cook, co-author of NEEDS-SEB and co-creator of Character Strong, was contracted to work with CCS staff to tailor the program to align to the unique needs of the CCS educational and campus environment. An additional \$16,500 was allocated this year to begin the retraining and reimplementation process.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Action 2.1 - PPS School Counselor: This was an effective action as our school counselor directly supported student mental health with social-emotional learning.

Action 2.2 - Character Strong: This continues to be a work in progress. This program will be braided with the NEEDS-SEB reboot in 2026-27.

Action 2.3 - Restorative Practices: Implementation continues to grow. RP will be a greater focus in the coming school year.

Action 2.4 - NEEDS-SEB: This program will effectively be "rebooted" in 2026-27. Dr. Clay Cook will be joining the CCS team for training.

Action 2.5 - Cultural Diversity, Equity, and Inclusion training: Both CCS and Hance serve a diverse student population. Kno'Qoti Native Wellness, Inc. provided several trainings throughout the school year to the Hance staff and students.

Action 2.6 - BCBA - Senior Director: The BCBA is working with students and staff to reduce intensive, negative behaviors. This was an effective action.

Action 2.7 - Healthy Start Services: This continues to be an effective action. Healthy Start staff work with our students and families in need offering support from a variety of community resources.

Action 2.8 - Family Engagement Activities: Family engagement has increased which has positively impacted our school culture and environments. This was an effective action.

Overall success from this goal is evidenced in reduced suspensions for CCS and improved attendance for Hance.

CCS and Hance have a large turn over in students throughout the school year. Greater attention and focus to the restorative practices will be needed in the upcoming year. CCS will undergo a NEEDS-SEB reboot in 2026-27 with the hope to improve implementation with greater consistency.

Students attending Lloyd P. Hance Community School and Clearlake Creativity School come to our campuses with a myriad of challenges. Preparing them for a smooth transition back to their district of residence, developing a plan for life after high school, and teaching them self-regulation are all critical elements for post-secondary success. From the engagement meetings held, students and staff reinforced the need for additional student supports focused on college/career readiness. Designating a PPS School Counselor to both campuses would support all students with post-secondary planning that included potential internships and the creation of a student's 10-year plan. Equity multiplier funds were targeted for the PPS School Counselor to support this goal.

## Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

This goal was primarily focused on implementing Big Picture Learning and the NEEDS-SEB program with a greater level of fidelity. Both Hance and CCS experienced some significant adjustments in staffing in 2025-26. Hance had a new teacher added to the team and accepted several new students from several high schools. CCS added a new teacher at the start of the school year, welcomed back a teacher returning from a leave which resulted in transferring a teacher mid-year, reorganized mental health services as the Clinical Director moved offices which transitioned student case loads to the resident clinician, and new students were added to the roster. These staffing adjustments required all teams to adjust to new personalities both from students and staff which can be challenging given the circumstances of our student enrollment. Staff and students adjusted as best as possible. These changes in staffing prompted a reboot of the NEEDS-SEB program and continued training in Big Picture Learning.

No material differences between budgeted expenditures and estimated actual expenditures occurred.

Action 3.3 - Leave-to-Learn (internships): More work-based experiences were available to students in 2025-26. This was an effective action.

Action 3.4 - Career Portfolios: This continues to be a work in progress for our PPS School Counselor. An electronic version is being explored for 2026-27.

Action 3.5 - Student Engagement Incentives: Student incentives were effective in improving individual attendance; however, inconsistent transportation for Hance students continues to be a challenge.

As we move into 2026-27, the Hance team will attend the Big Picture Learning Conference (Big Bang) in July 2026 and Dr. Clay Cook will be working with the CCS staff in 2026-27 to help improve implementation of the NEEDS-SEB program.

## Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California Education Code [EC] Section 52064[e][1]). - **Student Group(s):** Indicate the student group or groups who will be the primary beneficiary of the action by entering "All," or by entering a specific student group or groups.
- **Contributing to Increased or Improved Services?:** Type "Yes" if the action **is** included as contributing to meeting the increased or improved services requirement; OR, type "No" if the action is **not** included as contributing to meeting the increased or improved services requirement.
- If "Yes" is entered into the Contributing column, then complete the following columns:
  - **Scope:** The scope of an action may be LEA-wide (i.e., districtwide, countywide, or charterwide), schoolwide, or limited. An action that is LEA-wide in scope upgrades the entire educational program of the LEA. An action that is schoolwide in scope upgrades the entire educational program of a single school. An action that is limited in its scope is an action that serves only one or more unduplicated student groups.
  - **Unduplicated Student Group(s):** Regardless of scope, contributing actions serve one or more unduplicated student groups. Indicate one or more unduplicated student groups for whom services are being increased or improved as compared to what all students receive.

The LEA reviews the original estimated cost for the action and determines that had it hired additional staff to collect and analyze data and to coordinate supports for students that estimated actual cost would have been \$169,500 due to a cost of living adjustment. ### **Contributing Actions Table**

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
  - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### **Contributing Actions Annual Update Table**

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7).   - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
  - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

## **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
