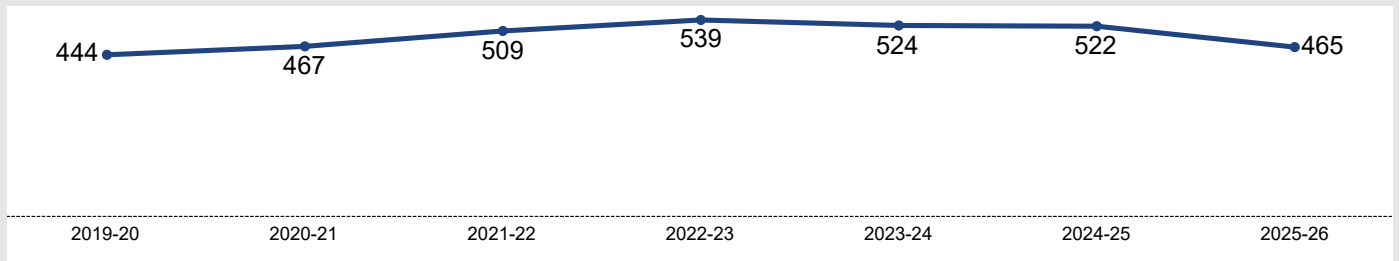

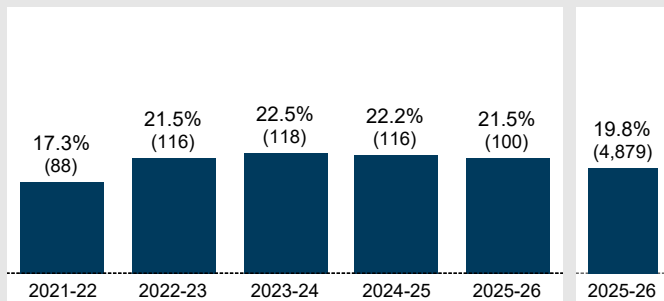

Enrollment History

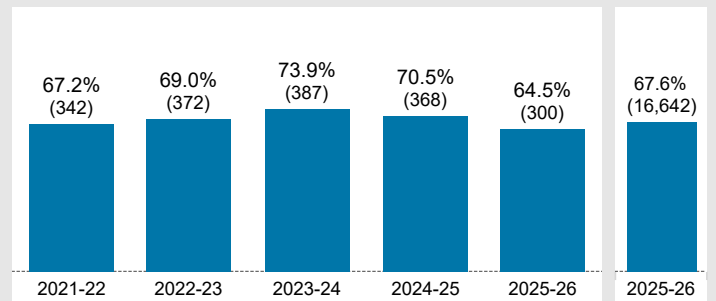


Students with IEPs

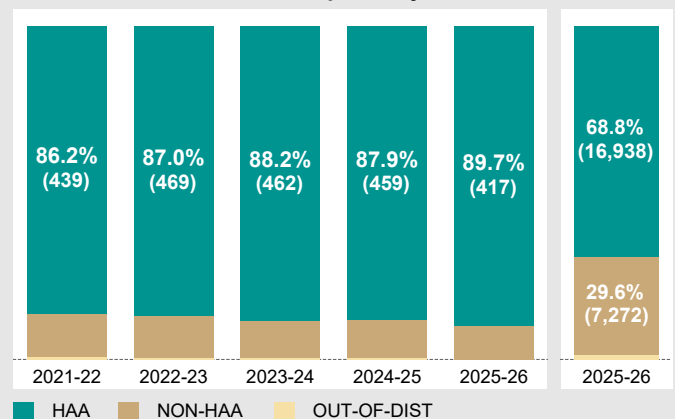

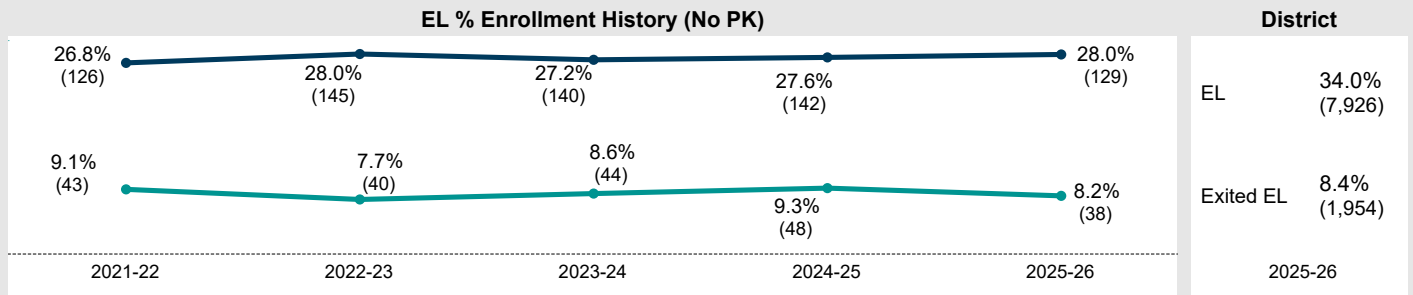

**Students with IEPs:** Percent and count of students qualifying and receiving special education services.

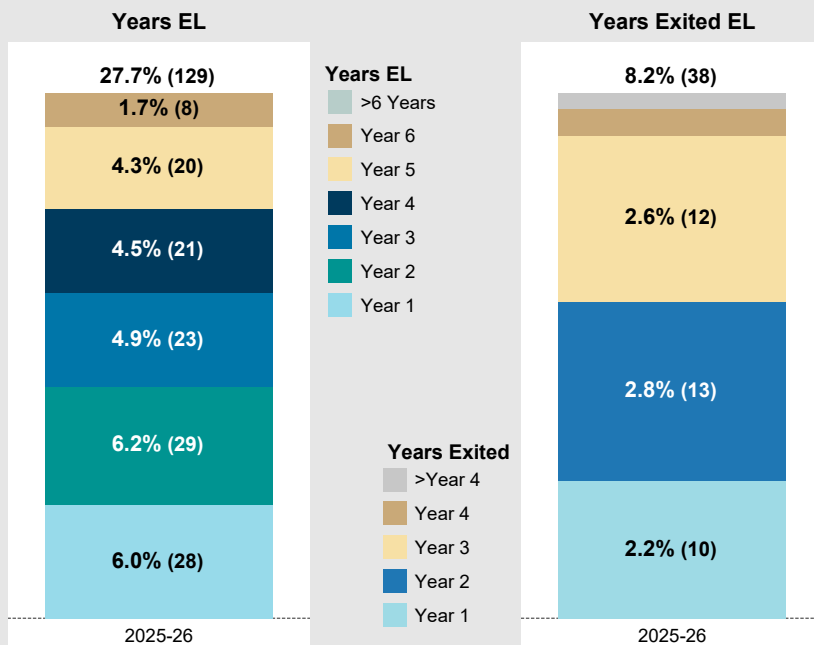

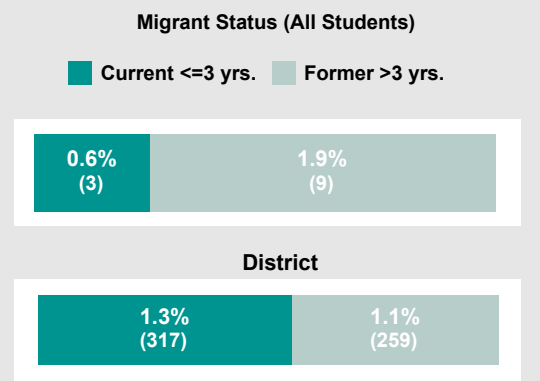
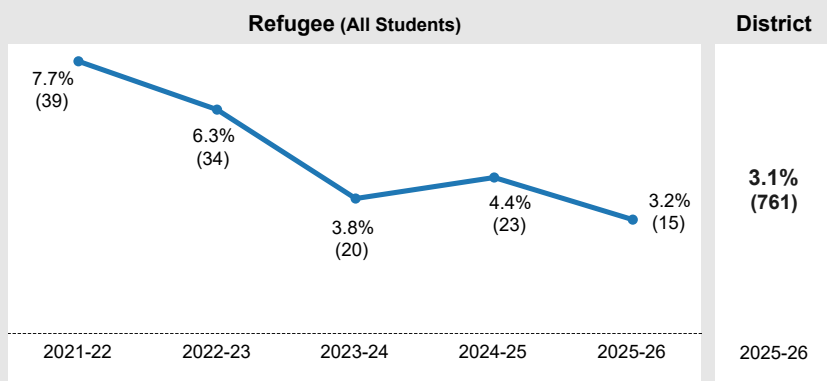

This information can be used as one measurement of family engagement.

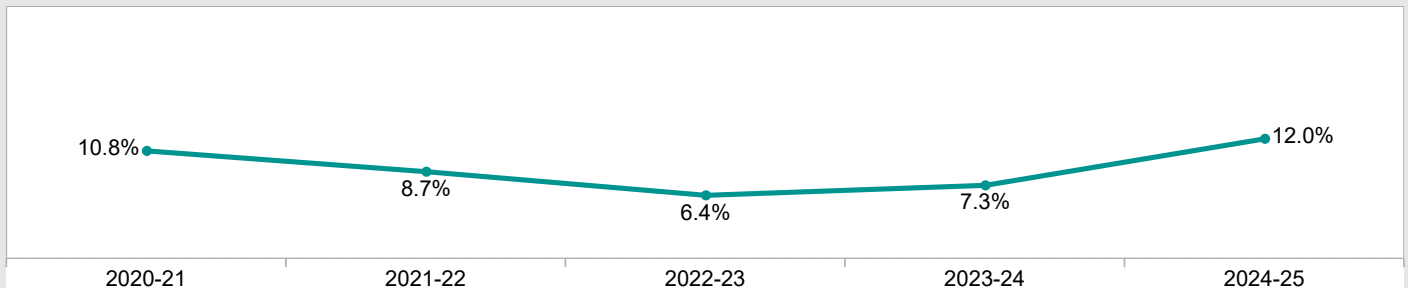
This report displays the number of students who had at least one or more parent/guardian attend PTC in person or by phone/virtually.

### Student Mobility



**Data Source:** NDE NEP website. Nebraska Student and Staff Record System

**NEP Definition:** Any child who enters or leaves school between the last Friday in September and the last day of school is counted in the mobility rate. An individual child is counted only once. The percentage is calculated using the number of students in grades K-12 who are mobile divided by the number of students in grades K-12 as reported in the October or Fall membership. The October or Fall membership includes students enrolled on the last Friday in September.

If school level statistics do not appear, no data was available. Mobility percentages lag one year behind due to the timing and availability of the data.

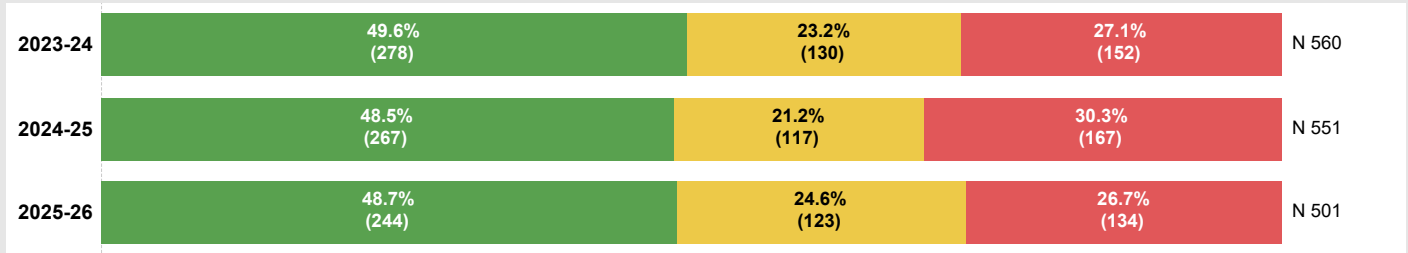

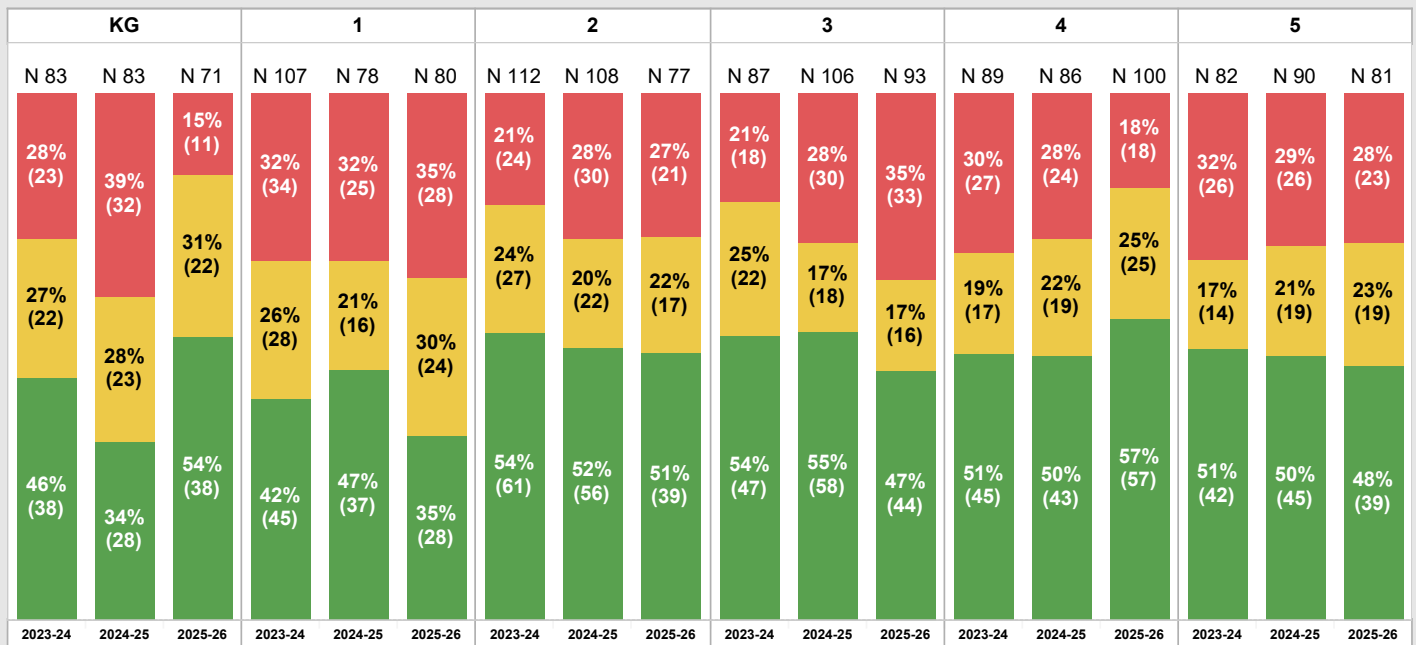

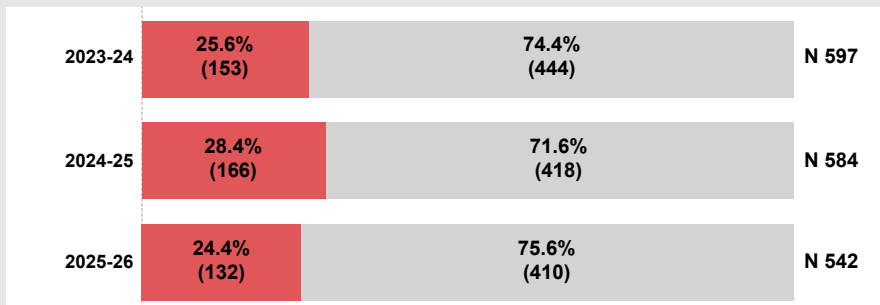
## Percent Absent by Grade: Enrolled 10 or More Days

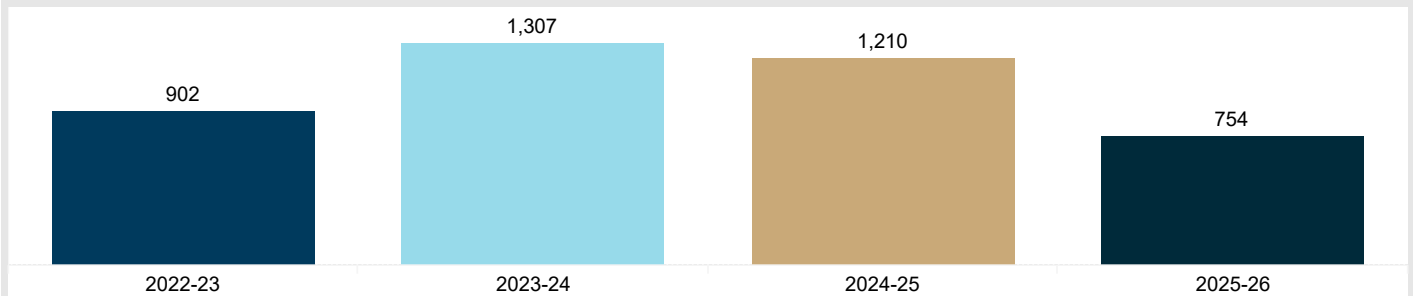

**Early childhood students are not included in any demographic or discipline counts.** Student demographics are based on Official Fall Membership enrollments and all discipline rates by group or school are calculated by dividing the number of students disciplined throughout the school year by the number of students enrolled at official membership.

Unique Student Incidents by School Year reflects the total number of distinct students involved in distinct incidents in that school year. A student involved in multiple unique incidents counts multiple times.

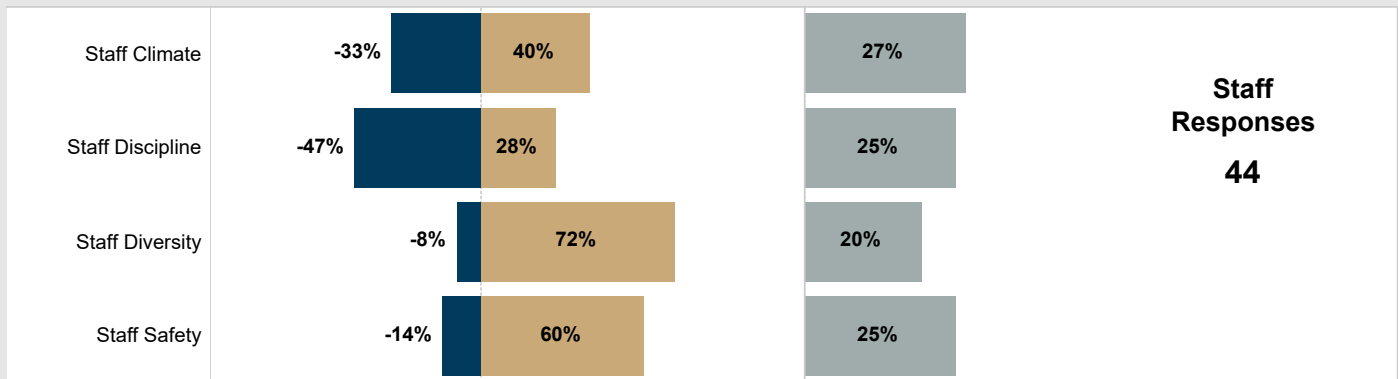

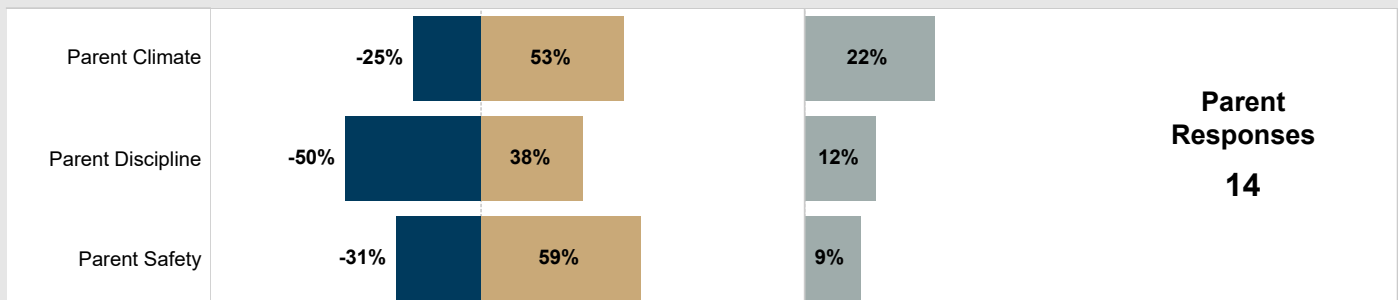
