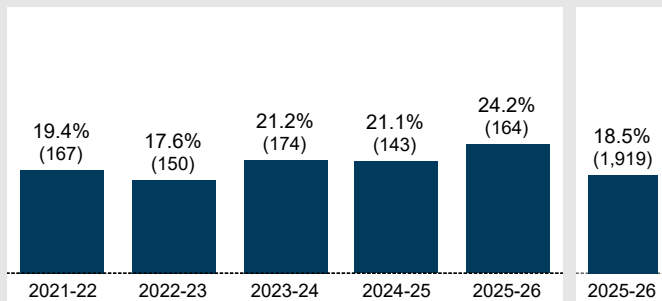

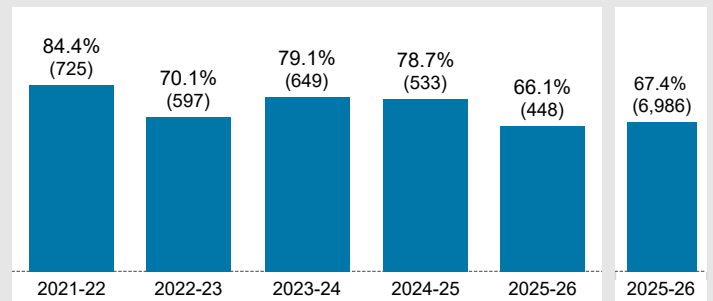

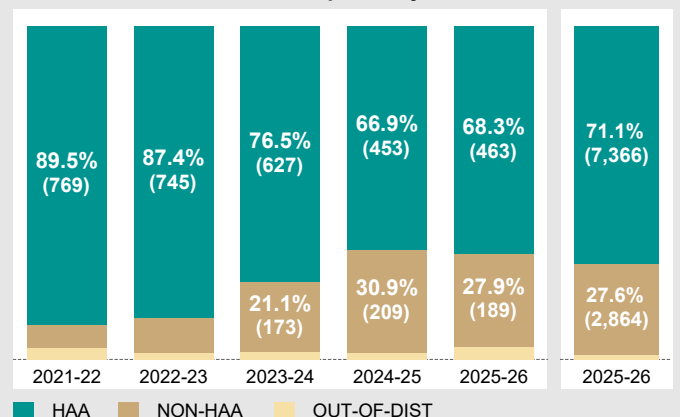

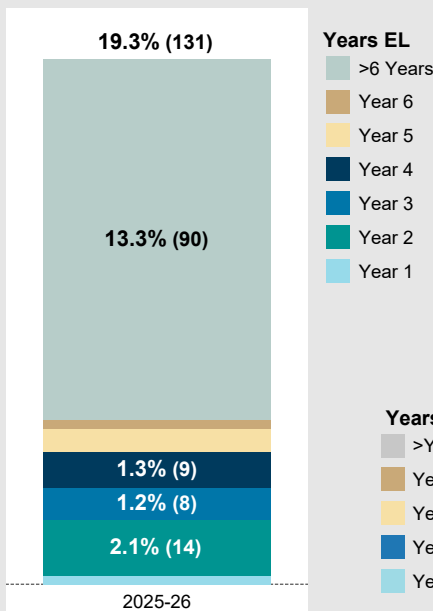

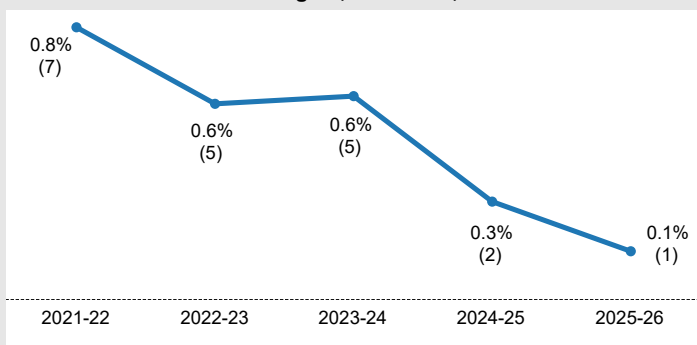

Beginning with the 2021-22 school year, the Research Division collected both fall and spring parent-teacher conference data which includes in person and virtual attendance. This information can be used as one measurement of family engagement.

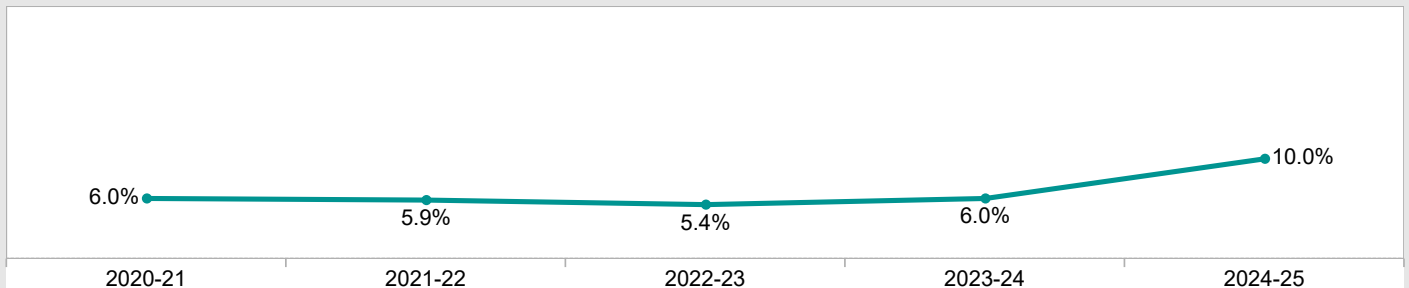
This report displays the number of students who had at least one or more parent/guardian attend PTC in person or by phone/virtually.

NEP Definition: Any child who enters or leaves school between the last Friday in September and the last day of school is counted in the mobility rate. An individual child is counted only once. The percentage is calculated using the number of students in grades K-12 who are mobile divided by the number of students in grades K-12 as reported in the October or Fall membership. The October or Fall membership includes students enrolled on the last Friday in September.

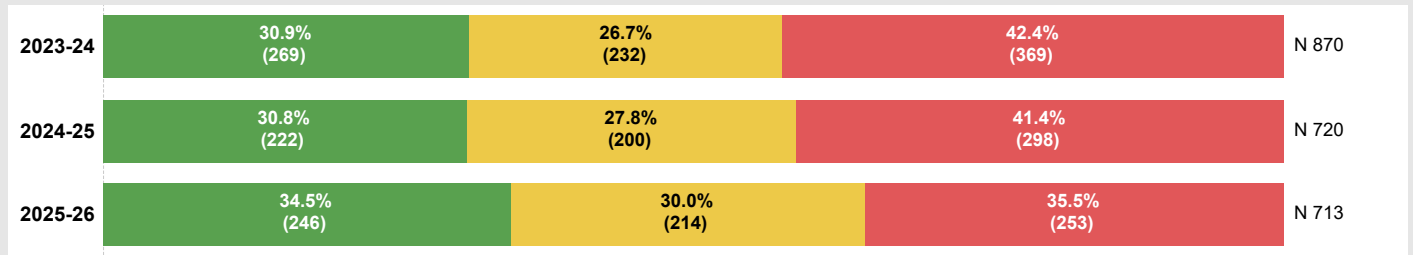

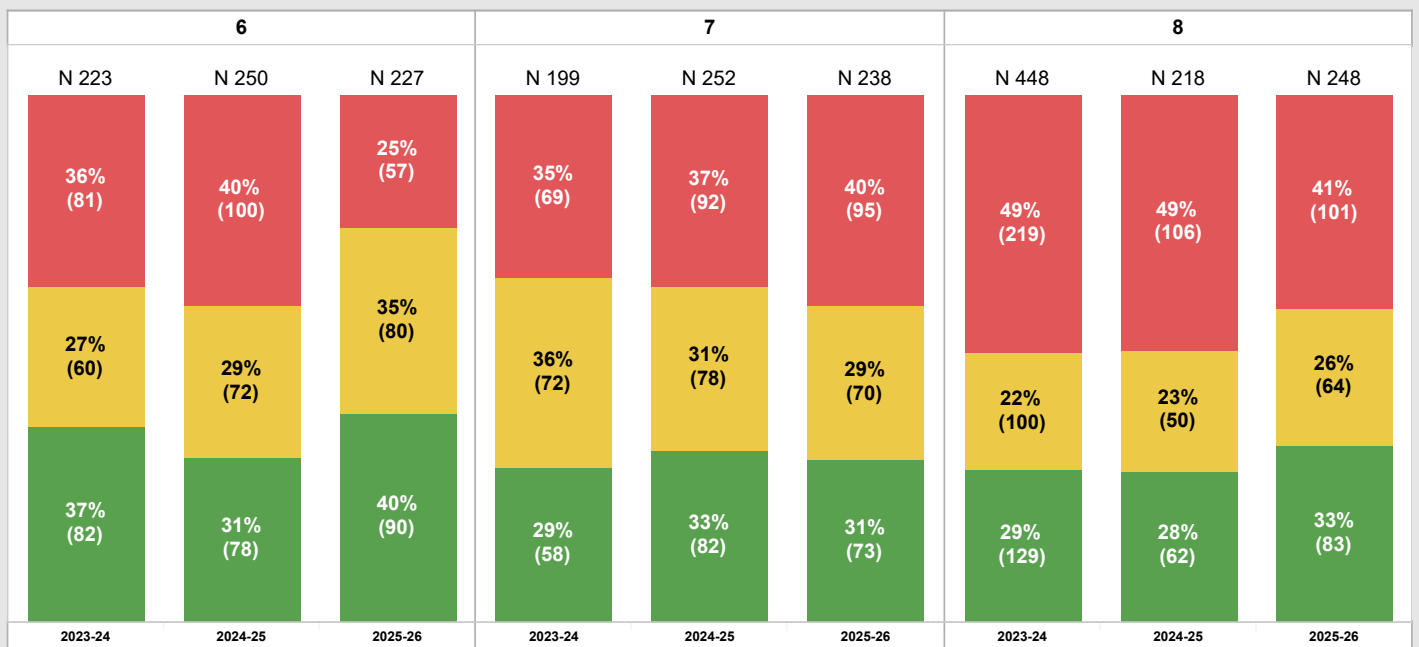

 ■ Chronic >10%

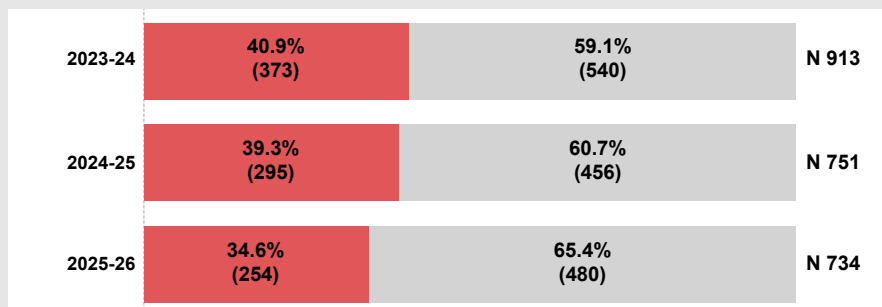
Percent Absent by Grade: Enrolled 10 or More Days

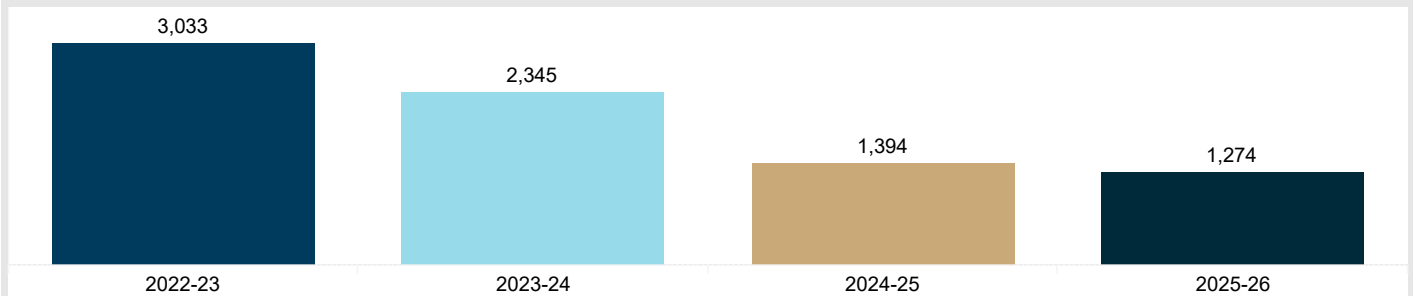

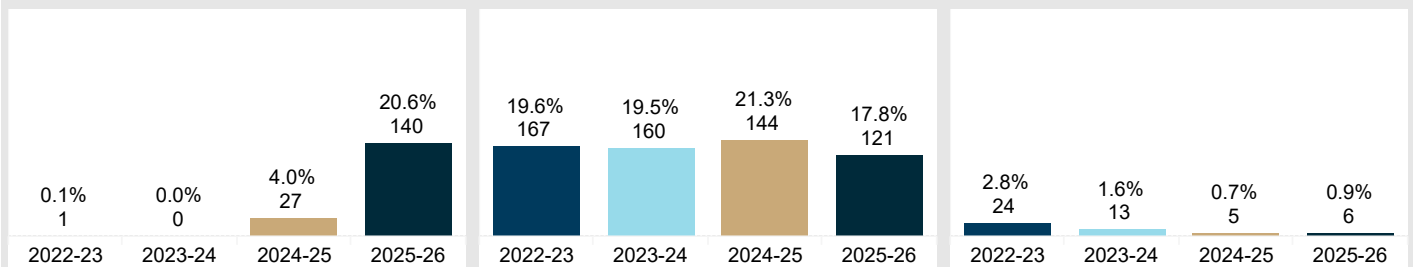
Unique Student Incidents by School Year

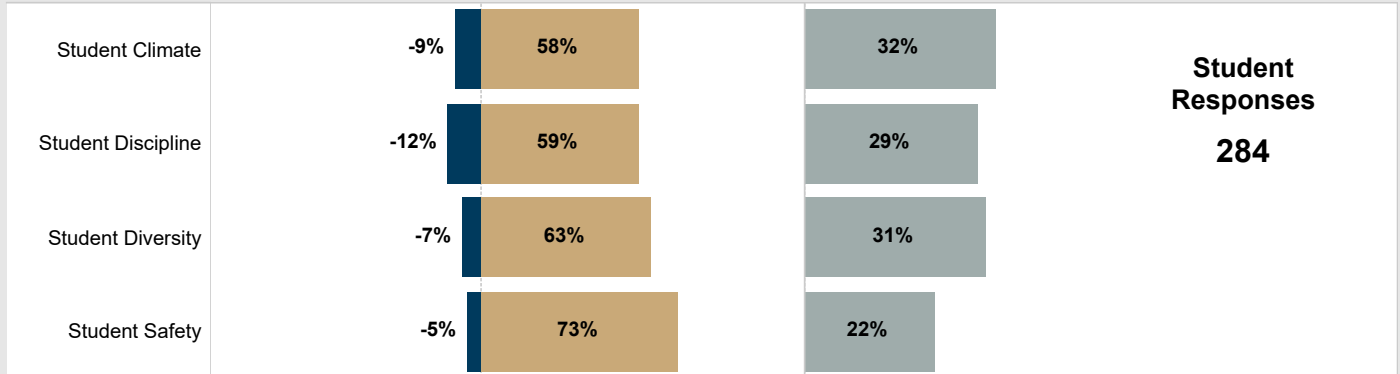
Unique Student Incidents by School Year reflects the total number of distinct students involved in distinct incidents in that school year. A student involved in multiple unique incidents counts multiple times.

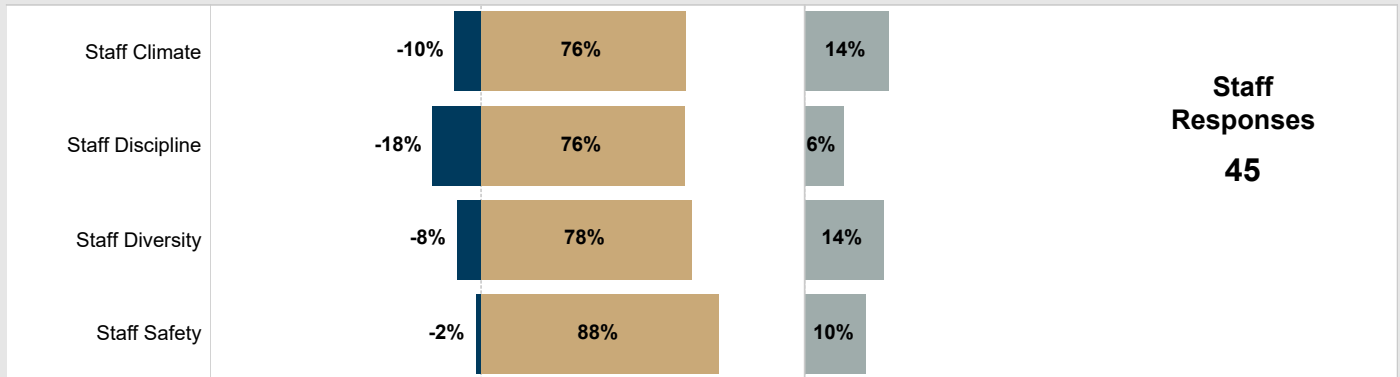

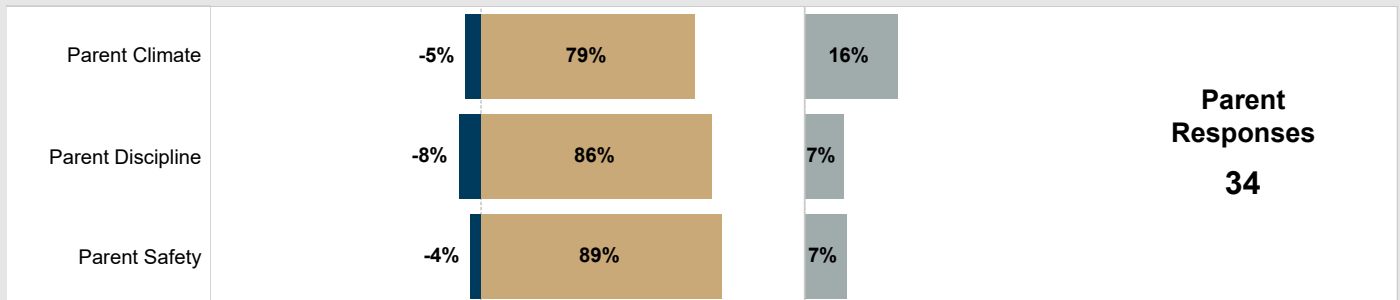
Student Climate Survey
