Dear Murrieta Valley USD Community:

The notification will identify the active ingredient or ingredients in each pesticide product and will include the internet address of the California Department of Pesticide Regulation (www.cdpr.ca.gov) for further information on pesticides and their alternatives.

Upon request, the school district is required to supply information about individual pesticide applications at least 72 hours before application.
