



GOVERNING BOARD RESOLUTION IN SUPPORT OF MILITARY-CONNECTED STUDENTS AND FAMILIES AND PURPLE STAR SCHOOL DESIGNATION FOR MAS CHARTER SCHOOL YALE CAMPUS

WHEREAS, members of the United States Armed Forces, including active-duty service members, members of the National Guard and Reserves, and veterans, have served our state and nation with commitment, and their families share in the responsibilities and sacrifices that accompany military service; and

WHEREAS, military-connected students bring unique experiences and perspectives to their schools and communities while also navigating challenges that may include frequent school transitions, separation from a parent or caregiver, changes in academic programs, and the social and emotional demands associated with military life; and

WHEREAS, Mission Achievement and Success Charter School's Yale Campus (MAS 1.0) leadership and team members believe every student deserves access to a high-quality college-preparatory education, meaningful support, and a school community committed to helping them succeed, regardless of their background or circumstances; and

WHEREAS, Mission Achievement and Success Charter School is committed to creating an intentionally structured, supportive, and engaging learning environment where students are known, challenged, and offered the resources they need to grow academically, personally, and socially; and

WHEREAS, New Mexico is a member of the Interstate Compact on Educational Opportunity for Military Children, which addresses educational transition issues affecting military-connected students, including enrollment, placement, attendance, eligibility, and graduation; and

WHEREAS, the New Mexico Purple Star School program recognizes schools that demonstrate a meaningful commitment to supporting military-connected students and families and reducing barriers as students transition between schools and communities;

NOW, THEREFORE, BE IT RESOLVED, that the Governing Board of Mission Achievement and Success Charter School affirms its support for military-connected students and families and recognizes the service, resilience, and sacrifices of those who serve our nation and the families who serve alongside them at our Yale Campus; and

BE IT FURTHER RESOLVED, that Mission Achievement and Success Charter School commits to pursuing and maintaining Purple Star School designation and to providing military-connected students and families with intentional, accessible support, including:

- A Designated Point of Contact at the Yale Campus: Identifying and supporting a trained staff member to serve as a primary point of contact for military-connected students and families.
- Accessible Resources: Maintaining dedicated online information and resources to help military-connected families navigate enrollment, school transitions, and available school and community supports.



- Support During Transitions: Helping incoming and outgoing military-connected students successfully navigate academic, social, and school transitions.
- Professional Learning: Providing appropriate professional development so staff members better understand the experiences and needs of military-connected students and are prepared to support them effectively.
- Recognition and Appreciation: Creating opportunities for the Mission Achievement and Success Charter School Yale Campus community to recognize military-connected students, families, veterans, and service members and to honor the contributions associated with military service.

BE IT FURTHER RESOLVED, that Mission Achievement and Success Charter School will approach this commitment as it approaches the education of every student: with high expectations and purposeful support, as well as the belief that circumstances should never determine a young person's potential.

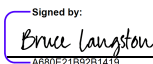
